Set packer at 5778' & squeezed Tubb-Drinkard zone 7" casing perforations 5886' to 5948' with 100 sx. Class "C" cement and 300 sx. Chem-Com. Cement. Drilled out cement and tested 7" casing with 800#. Held OK.
