The Montoya zone was temporary abandoned 4-14-71, due to tubing leak, by setting a plug in the Montoya tubing at 6891'.

Coates "C" well #7, completed in the Montoya zone, is currently pumping 14 BOPD from the same proration unit as well #14.

It is proposed to pull the plug from the Montoya tubing, run 1,405' of 1" J-55 integral joint fiberglass wrapped liner in the Montoya tubing, pack-off at 6891' in seating nipple, with mechanical pack-off @ 5485' to eliminate communication, and put Montoya back on production.

Montoya production from both wells is expected to be below unit allowable.

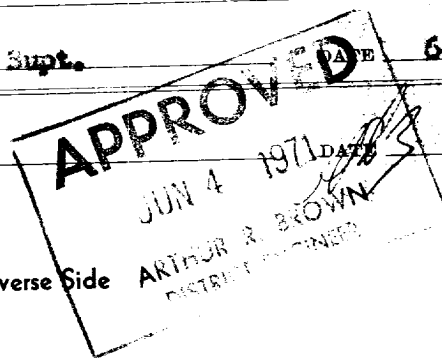

Instructions
