This well is currently HIO - (Montoya Perforations 6708-6920'). It is proposed to plug off perforations 6910-20' and additionally perforate the Montoya and frac as follows:

Set 7' CIBP at 6900' and dump 10' cement on top.

Additionally perforate Montoya, selectively from 6701-64'.

Treat all Montoya perforations with 60,000 gals. gelled brine and 80,000# sand.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
