Well is a dual oil, completed in the Ellenburger (7514-35') and McKee (7315-7440'). The Ellenburger zone is NFO, the McKee is pumping 1 BW and 3 BWP.

It is proposed to abandon the Ellenburger and McKee zones; complete in the Montoya as a single oil completion as follows:

Pull pump and tubing from McKee, and tubing from Ellenburger zone. Set a Baker "DH" plug in the Model "D" packer @ 7750' and dump 10' of cement on top of the "DH" plug. Set a cast iron bridge plug at 7275'. Dump 10' of cement on top of the CIBP. Perforate Montoya zone with one shot at each setting, 6768, 69, 70, 74, 76, 89, 97, 99, 6801, 08, 10, 18, 20, 22, 43, 47, 51, 58, and 59' as read from the Collar log.

Treat with 3,000 gals. of 15% suspending HCl acid with 30 ball sealers. Swab test and put on production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 14: Needed only when location of well cannot readily be found by road from the land or lease description. A plat, or plats, separate or on this reverse side, showing the roads to, and the surveyed location of, the well, and any other required information, should be furnished when required by Federal or State agency offices.
