This is a single pumping completion in the Tubb-Drinkard. It is proposed to dually complete the well in the entire Blinebry interval. Well No. 26 in the same proration unit, is producing approximately 10 BO and 75 MCF gas per day.

Work to be performed as follows: Run Gamma Ray Correlation Log from 5850' to 4000'. Perforate 5060, 63, 65, 86; 5112, 20, 61, 63, 82, 85, 94, 97; 5235, 38, 41, 60, 80, 88, 98; 5300, 02, 13, 34, 48, 58, 73, 82; 5410, 12, 15, 17, 52, 78, 82; 5503, and 40. (36 shots). Treat Blinebry perforations with 2250 gallons 15% HCL acid, 64,000 gallons gelled brine waterfrac and 104,000# 20/40 sand.

Pulled both strings tubing. Ran Baker "DR" plug on stand line and set in Model B Packer at 7150'. Lumped 10' cement on top. Perforated Tulsa Driskard Zone @ 5763, 77, 97, 99, 5801, 03, 20, 22, 28, 38, 53, 55, 57, 60, 75, 80 and 82' with one 1/2" jet shot at each interval. Ran retrievable BP and HTTS packer. Set BP @ 5893', tested BP to 2000#, OK. Released packer and left swinging. Spotted 250 gal. 15% NE FE HCL acid across perforations. Set packer @ 5925'. Acidized perforations 5763-5882' with 5,000 gal. 15% NE FE Hydrochloric acid using 25 ball sealers. Swabbed load. Filled with 50-50 brine water. Pulled HTTS packer and bridge plug. Ran Baker Model "B" tubing anchor catcher on tubing and set tubing at 5950', anchor at 5945'. Ran pump and rods.
