This well is currently producing 55 BO and 118 BW. It is proposed to squeeze off the existing perforations and perforate the Top of the Ellenburger as follows:

1. Pull rods, pump, and tubing,
2. Set a cement retainer at 7,730',
3. Squeeze off Ellenburger perforations 7,764'-82',
4. Perforate the Ellenburger Zone from 7,625'-27'; 7,637'-40' with 1 JSPP,
5. Acidize the new perforations with 1,000 Gals. Acid, and
6. Put the well on production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
