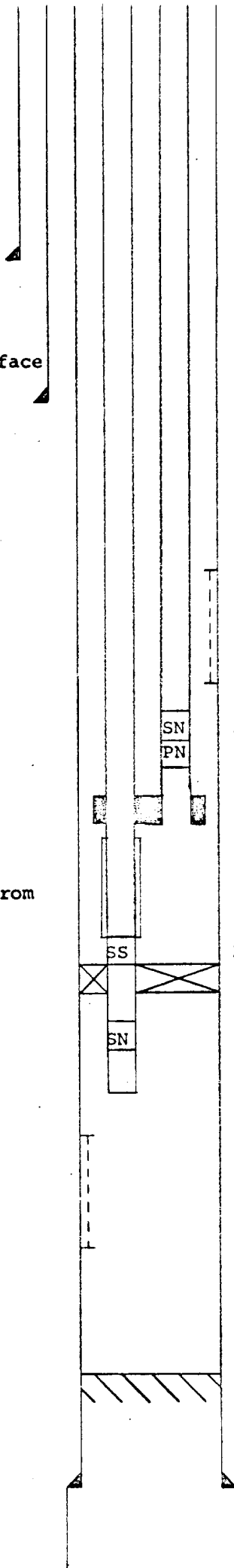

GAMMA RAY - S.P. CURVE

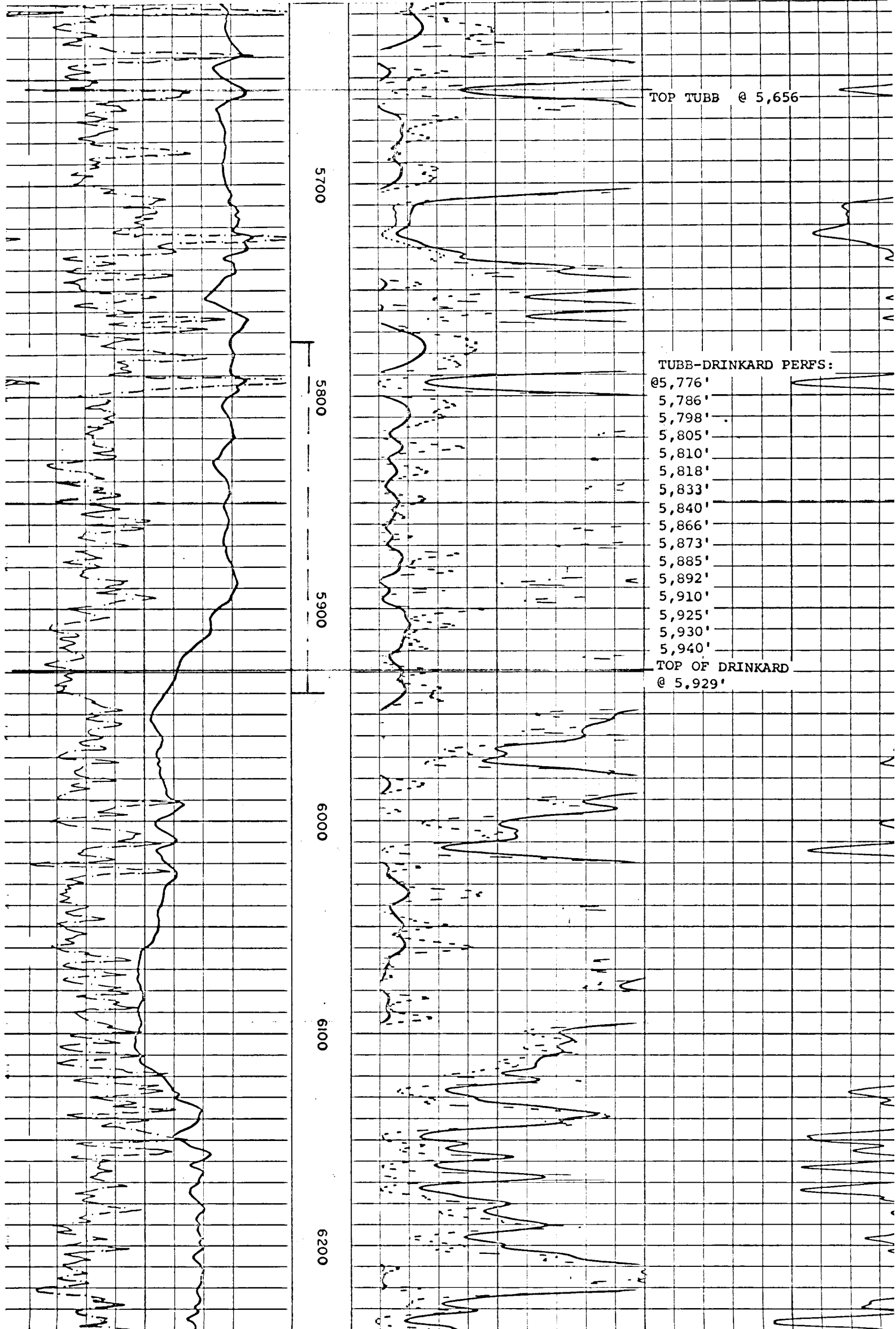
16" NORMAL, INDUCTION AND CONDUCTIVITY CURVES

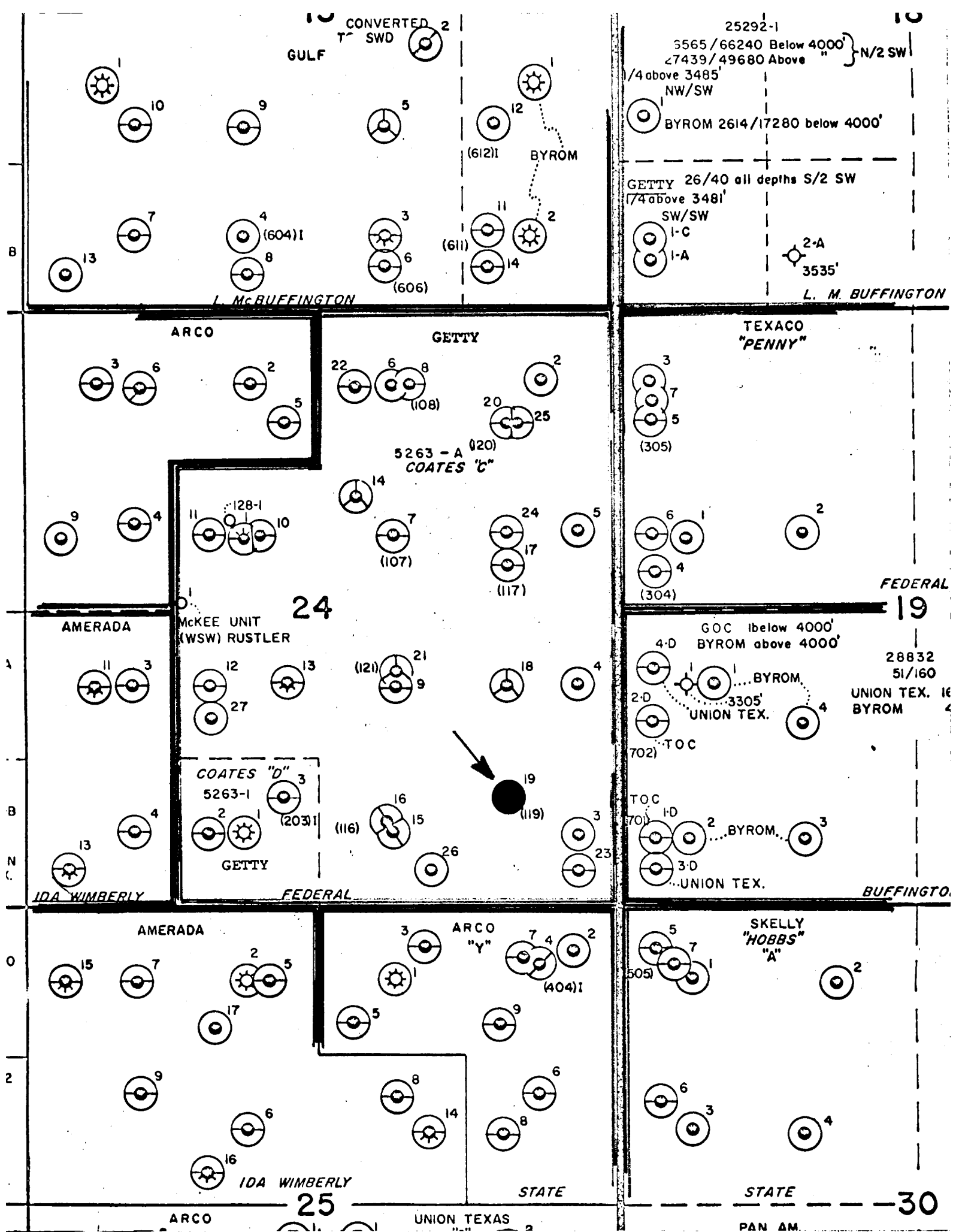

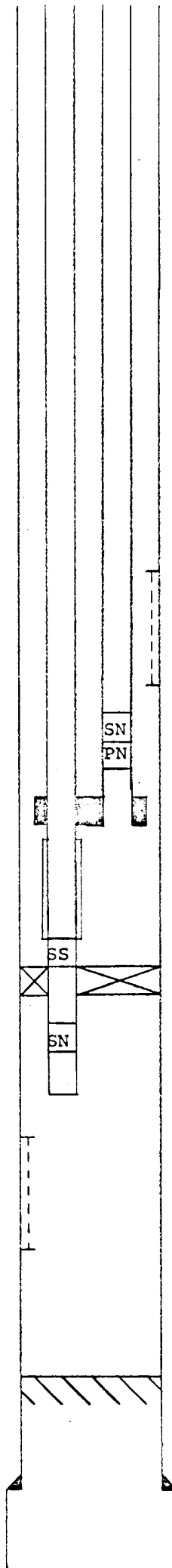

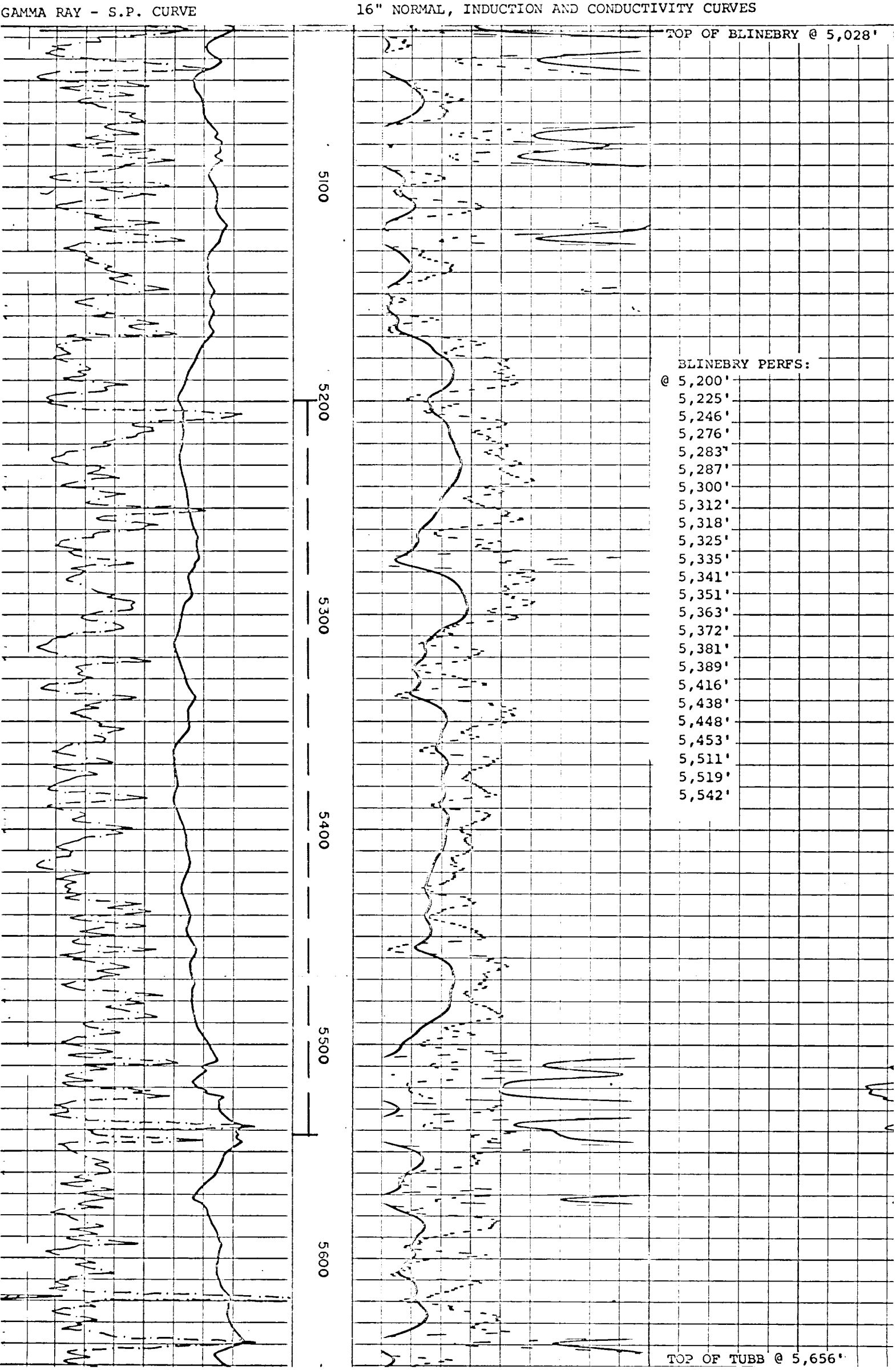
