2) SET CIBP AT 4975' - LOAD HOLE AND PRESSURE TEST CASING TO 500 PSI.

NOTE: PREVIOUS CASING LEAKS AT 3800' + - AND 4005-4040. IF CASING WILL NOT PRESSURE TEST, THEN SPOT A CEMENT PLUG (CLASS "C" NEAT) FROM 4100' TO 3700' (APPROX. 70 SX). THEN WOC FOR 12 HOURS AND RETEST CASING.

3) LOAD HOLE WITH INHIBITED WATER. *BLM*

4) NOTIFY NMOC and RUN MIT TO 500 PSI.

5) SEND CHART OF SUCCESSFUL TEST TO HENRY OFFICE % ROY JOHNSON AND TA WELL.
