5-24-00 Test sqzd to 550 PSI for 15 minutes. O.K. BLM rep on location. Tagged TOC @ 3148'. TIH & perf'd sqz holes @ 2158 w/ 4 shots. TIH & cut 7" csg @ 2158'.

5-25-00 Attempted to pull csg w/no results. TIH w/pkr & tbq. set pkr @ 1764'. Pumped & sqzd 60 sxs class C cement. Tagged TOC @ 1885'. Cut 7" csg @ 1695'. Recovered 46 jts of 7" csg, 1695'. TIH to 1764'.
