Propose to open up additional pay in the Blinebry by selectively perforating from 5020' to 5380'. Propose to open up additional pay in the Tubb-Drinkard by selectively perforating from 5720'-5790'. Both zones will be stimulated with acid and sand-oil frac.

Current Production (Blinebry) 129 barrels in July and (Tubb-Drinkard) 84 barrels in July. Top Blinebry 5010', Top Tubb 5690'.

Dual Blowout Preventers with offset rams and blanks will be used.
