It has been necessary to swab the Tubb/Drinkard zone in this well monthly since June, 1969 to produce any oil. Average T/Dkd production for last three months was 7.5 BOPM with 2/10% water. The Tubb/Drinkard zone has been shut in until such a time as remedial work is required on the Fusselman zone. No equipment has been pulled. Well is now producing only from the Fusselman zone.
