Drilled to 3335'. Ran 110 joints of 9-5/8" casing (32.3# and 36# H-40 ST&C and 36# J-55 LT&C), 3320.66', set at 3335.04'. Used 5 centralizers. BJ cemented with 750 sacks of Incor with 1/4# of Flocele per sack and 4% gel with 750 cuft of Diamix A followed with 200 sacks of Incor neat with 1/4# of Flocele per sack. Plug down at 9:30 AM 3-5-59. WOC. Tested 9-5/8" casing with 1000# from 9:30 to 10 AM 3-6-59. Test OK.


