6/18/02 POOH. RU Computalog and perforate Yates from 2450'-2480', 2490'-2510', 2520'-2530', 2545'-2560', 2600'-2610', 2650'-2670', 2715'-1725'. RD Computalog & TIH w/4 5/8" bit + DC's + tbg. Make 1 more foot on cement retainer on top of liner. POOH, release reverse unit & SDFN.

6/19/02 Open well. TIH w/ RBP + Model R Pkr + Tbg. Set RBP @ 2740. Spot 500 gal. 15% HCL across perms. Pulled 9 jts. & set Pkr @ 2400. Acidize with 2500 gal 15% HCL + 200 ball sealers.

6/20/02 Release Pkr & TOH. TIH w/tbg & catch RBP & POOH. Set CIBP @ 2680'. TIH w/pkr + tbg to 2634. Swab test. Good gas shows.

6/21/02 Release pkr & TOH w/tbg & pkr. TIH w/BPMA + Perf Sub + Baker AD-1 Packer + SN + 12' pump barrel + 84 jts tbg. NU wellhead & TIH w/4' plunger + 106 3/4" rods. Put well back into production.
