## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled top plug and tested with 1000# pump pressure for one hour with no loss in pressure. Drilled lower plug and 12' of formation; tested with 1000# pressure, which dropped to 250# within 30 minutes. Swabbed hole down and found formation below pipe making one bbl. of sulphur water per hour. Attempted two squeeze jobs without success. Drilled ahead to 3120'; set 5 $\frac{1}{2}$ " liner from 2850-3120 and cemented with 40 sac. Let set 48 hours, drilled plug and tested with 1000# pump pressure for one hour, without loss.

Test satisfactory, now drilling ahead.
