Pulled rods & tubing. Ran correlation log. Perforated two 1 1/2" holes @ 5311, 5218, 5194' & 5172'. Ran straddle packers and acidized each of the above perfs individually w/500 gals. acid each. Pulled straddle packers, ran 7" treating packer on 4" tubing, set packer @ 5112'. Fraced down 4-1/2" w/30,000 gal lease oil w/ 1/20# Adomite per gal. & 45,000# 20-40 mesh sand. Pulled 4" tubing & treating packer. Ran 2-3/8" tubing & swabbed to production. Well flowed for two days and died.

Ran pump & rods & commenced pumping.

Well is now producing from the above mentioned new perfs. plus the following old perfs, 5064-84, 5264-74, 5359-64, & 5391-95.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
