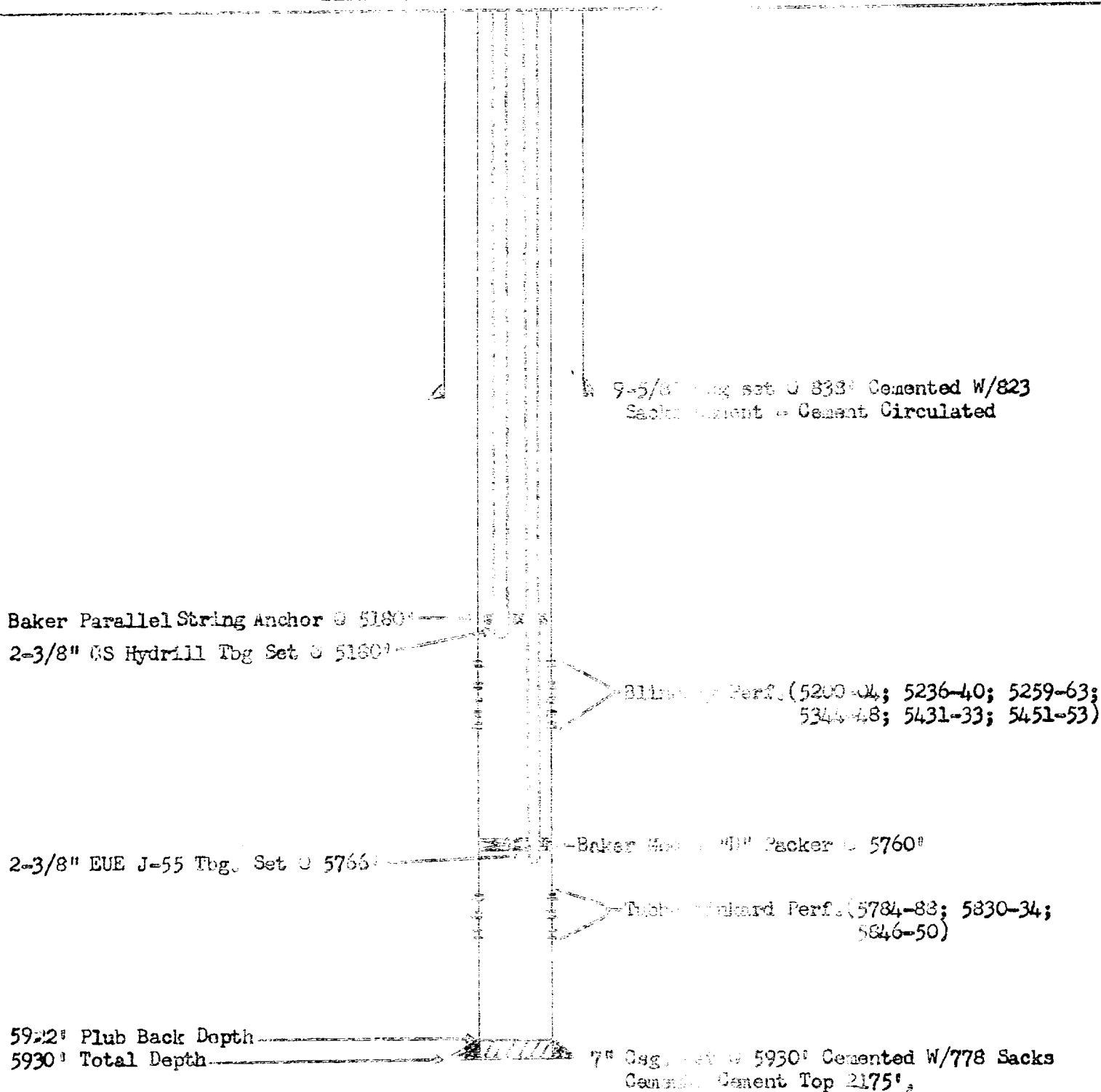

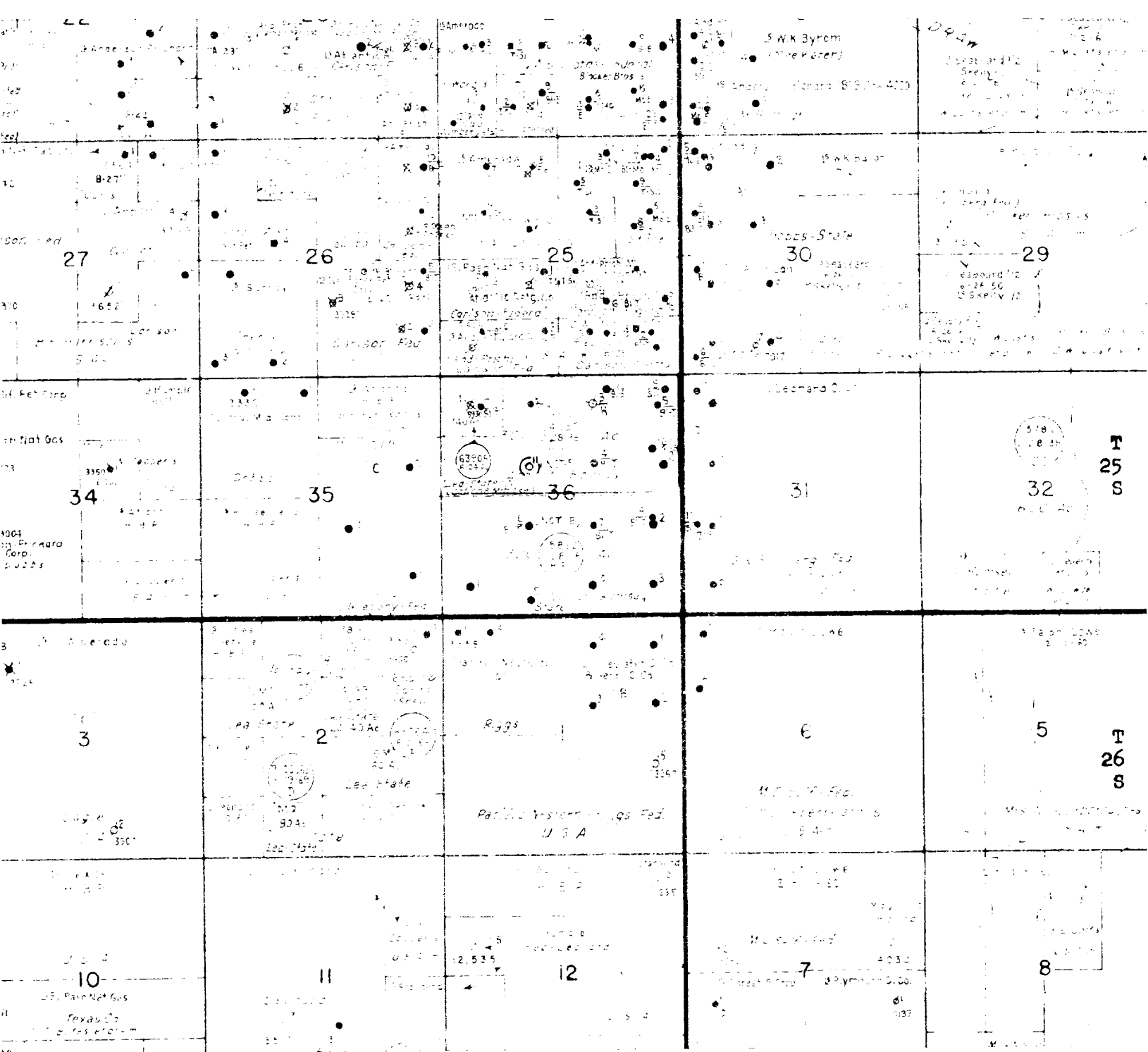
Diagrammatic Sketch of Mechanical Installation
