Dear Sir:

Your administrative approval is requested for an exception to Rule 303-A to permit down-hole commingling of production in the subject well from the Justis Blinebry and the Justis Tubb Drinkard Pools (commingled in surface storage by Administrative Order PC-15). Production from the same two pools is presently being commingled down-hole in Gulf's Arnott-Ramsay (NCT-F) No. 11 per Order No. DHC-48. There is no evidence of fluid incompatibility, and we do not expect any reservoir damage due to down-hole commingling in the well bore. Ownership in the two pools is common and correlative rights will not be violated.

Currently this well utilizes a dual pumping unit installation. If down-hole commingling is permitted, the existing pumping equipment on the Justis Tubb Drinkard will be utilized to lift the fluids from the two commingled zones. We propose to tube the well through the Justis Tubb Drinkard zone and keep the well pumped down to prevent crossflow between the two zones.

Additional information concerning this application as outlined in Rule 303-C, is attached for your consideration.

- (6) Fluid Characteristics: Justis Blinebry and Justis Tubb Drinkard are presently being commingled downhole in Gulf's Arnott-Ramsay (NCT-F) No. 11, Order No. DHC-48, dated 6-27-70. There has been no evidence of fluid incompatibility.
- (7) Value of Commingled Fluids: Justis Blinebry and Justis Tubb Drinkard production are presently being surface commingled on this lease per Administrative Order PC-15. Since production is already being commingled on the surface, down-hole commingling will not affect the price.
- (8) Current Production Tests:

Justis Tubb Drinkard (3-7-78) pumped 14 BOPD, 6 BWPD, 38 MCFPD, GOR 2714

Application To Commingle Down Hole															

No well will be assigned an allowable greater than the amount of oil produced on the official test.

During gas-oil ratio test, each well shall be produced at a rate not exceeding the top unit allowable for the pool in which well is located by more than 25 percent. Operator is encouraged to take advantage of this 25 percent tolerance in order that well can be assigned increased allowables when authorized by the Commission.

Gas volumes must be reported in MCF measured at a pressure base of 15.025 psia and a temperature of 60° F. Specific gravity base will be 0.60.

Report casing pressure in lieu of tubing pressure for any well producing through casing.

Well original and one copy of this report to the District Office of the New Mexico Oil Conservation Commission in accordance with Rule 301 and appropriate pool rules.

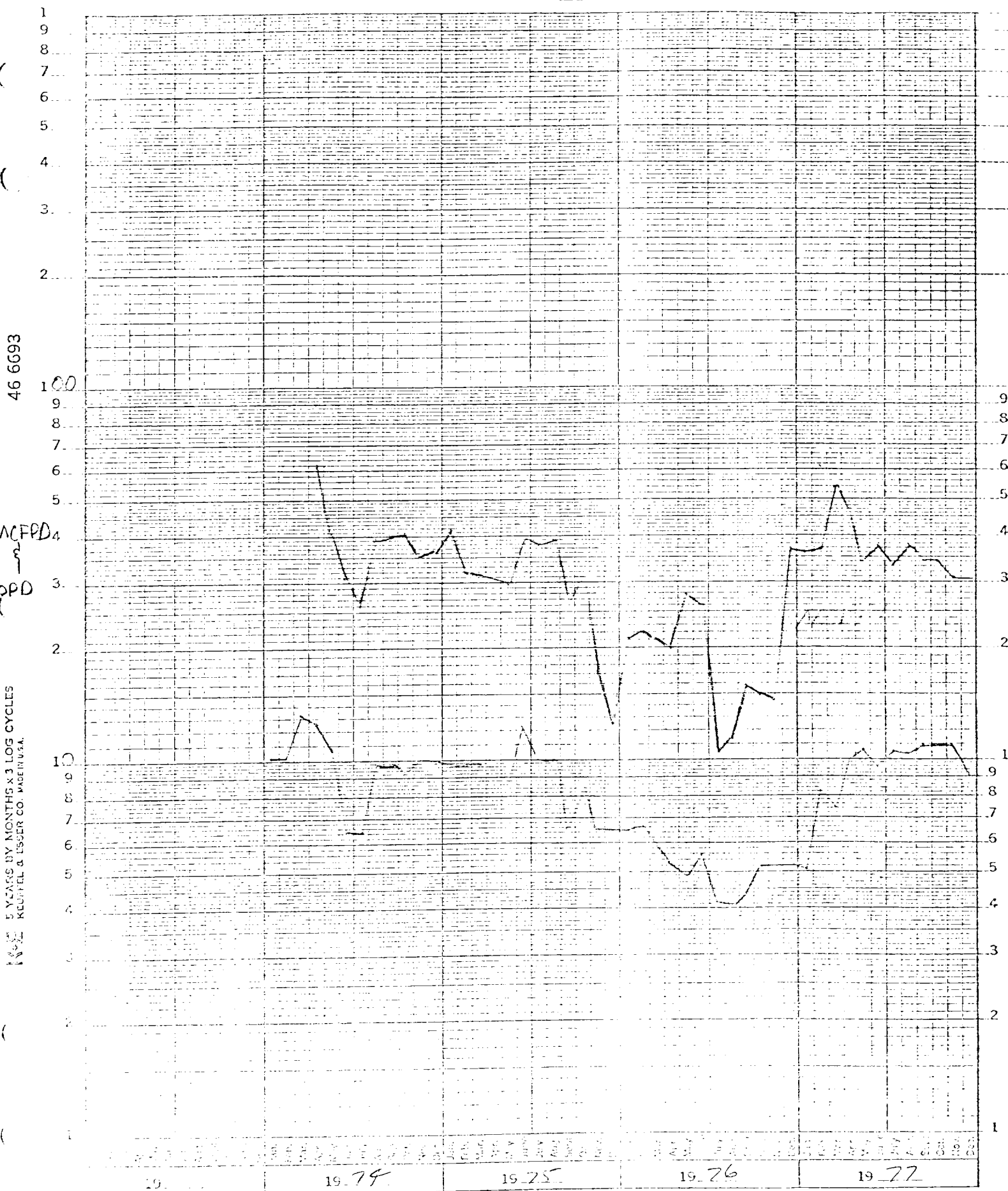
