



If, after said twenty-day period, no protest nor request for hearing is received by the Santa Fe office, the application will then be processed.
- NOTE: If the proposed dual completion will result in an unorthodox well location and/or non-standard perforation unit in either or both of the producing zones, then separate application for approval of the same should be submitted previously with this application.
