DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled to total depth of 9177' and plugged back to 8221' with 257 sacks of cement. Ran 5-1/2" OD casing to 8221' and cemented with 700 sacks of cement. The Halliburton process was used and top of cement found at 4704'. Let cement set 72 hours and on November 13, 1951, at 1:30 a.m. tested casing shut-off. Shut-off tested o.k.
