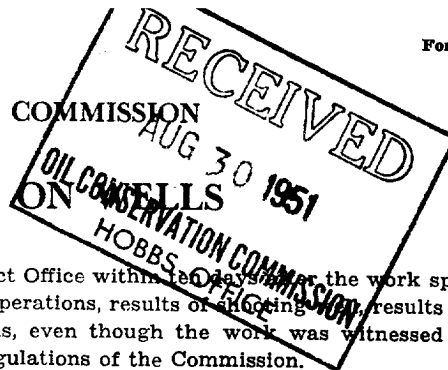

## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled to total depth of 3250'. Ran 9-5/8" CD casing to 3250' and cemented with 1800 sacks using the Halliburton process. Cement circulated to surface. Let cement set 48 hours and on August 30, 1951, at approximately 3:00 a.m. drilled plug and tested casing shut-off. Shut-off tested o.k.
