DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

TD 6525

Set 5 1/2" OD casing 6 6524 and cemented with 650 sacks of cement. Let set 72 hours and tested with 750# pump pressure for 30 minutes. No decrease in pressure.

Perforated 5 1/2" casing from 6415 to 6480 with 260 half inch jet holes. Swabbed all lo ad water and 15 barrels of new oil.

Acidized with 2,000 gallons of 15% low tension acid. Swabbed 10 hours, recovered 150 Bbl. of load oil and 45 Bbl. of new oil.

Acidised with 4,000 gallons of 15% low tension acid. Swabbed 66 hours, recovered 158 Bbl. of new oil. Last 24 hours recovered 68 barrels of oil.
