In an attempt to increase injectivity, the following work was done:

- 1) Acidized open-hole section 3675' - 3715' with 1,500 gallons of 15% Homogenized acid with 100# Iron Sequestering Agent added. Flushed with water.
- 2) Returned well to injection status injecting water into open-hole section 3675' - 3715' of the Queen formation at a rate of 224 bbls. per day at 1400#.
