- Spotted 10 sack cement plug surface to 21'.
- Installed dry hole marker.

No casing was pulled. The 9-5/8" OD 36# casing set at 290', the 7" OD 17# and 20# casing set at 3750' were left in hole. All intervals not cemented were filled with 10# mud.
