DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On December 16, 1952 at 10:00 A. M., 34 hours had elapsed since running 6989' of new 7" casing, landed at 7003 and cemented with 400 sacks cement plus 4% gel plus 400 cu. ft. Perlite. Top of cement, as indicated by temperature survey, is 4125.

Casing shut-off was tested with 1550 _____ before and 1600 psi for 30 minutes after drilling approximately 4' of cement. Since there was no appreciable drop in pressure on either test, completion operations were resumed.
