DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On March 1, 1953, at 8:30 P.M., 48 hours had elapsed since running 8040' of new 7" casing set at 8053' and cemented with 350 sacks cement plus 4% gel plus 350 cu. ft. perlite. Temperature survey indicated top of cement at 4825'.

Casing shut-off was tested with 1125 psi for 30 minutes before drilling cement to 8000'. Since there was no appreciable drop in pressure, completion operations were resumed.
