DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On January 10, 1953 at 10:00 A.M., 36 hours had elapsed since running 3120' of new 9-5/8" casing landed at 3135 and cemented in two stages as follows:

1st stage: Cemented with 210 sacks cement.

2nd stage: Cemented through staging collar set at 1229 with 150 sacks cement. Top of cement indicated by temperature survey is 975'.

Casing shut off was tested with 1500 psi for 30 minutes before and after drilling staging tool and with 1450 psi for 30 minutes after drilling shoe. Since there was no appreciable drop in pressure on any test, drilling operations were resumed.
