In an attempt to relocate the packer, communications developed.

Well was shut down on March 12, 1971, and we propose to temporarily abandon it by leaving it shut in until a study of remedial possibilities can be completed to confine injection to the main pay interval of the Drinkard and Abo zones. This will eliminate injection into the Tubb zone and the upper portion of the Drinkard zone which has been contributing to water breakthrough problems.
