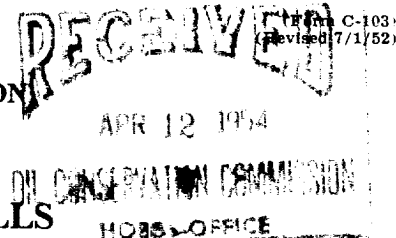

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On April 5, 1954, 3136' of new 9-5/8" casing was run in a 12-1/4" hole and cemented in two stages at 3150', with DV tool set at 1210' to isolate salt section. First stage cemented with 200 sacks neat. Second stage cemented with 150 sacks neat. After 30 hours WOC tested casing above DV tool and before and after drilling plug with 1000 psi for 30 minutes. Since there was no loss in pressure, drilling operations were resumed.
