Spudded 17 1/2" hole 3-27-54.

On March 27, 1954 new 13-3/8" casing was cemented at 318' with 190 sx. 4% gel plus 100 sx. neat. Cement circulated to the surface. After 30 hours WOC tested casing before and after drilling plug and as there was no loss in pressure, drilling operations were resumed.
