Spudded 12 1/4" hole at 10:30 P. M. 3/9/55.

On March 10, 1955, we ran 269' of 9" casing set at 280' and cemented with 260 sacks circulated to surface. After WOC for 30 hours, tested casing before drilling plug with 800 psi for 30 minutes. No drop in pressure. After drilling plug, tested casing with 800 psi for 30 minutes. No drop in pressure. Resumed drilling operations.
