- 4) Ran 227 jts. (6795') 2-3/8" OD tubing and set @ 6806'.
- 5) Ran rods and pump.
- 6) Returned well to production 9-3-73 producing 26 barrels oil and 26 barrels water per day from Drinkard perms. 6464-6830'.
