DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 90 joints 2884' of 8-5/8" OD 28# H-40 SS Casing. Set and cemented at 2900' w/1450 sacks cement, 1350 sacks 4% gel Lonestar regular and 100 sacks Neat on bottom. Plug at 2867'. Maximum pressure 1200#. B. J. Service temperature survey in 8 hours showed top cement at 1335'.

After waiting over 30 hours tested 8-5/8" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement plug from 2867' to 2900', tested cement below casing shoe w/800# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
