DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Acid treated open hole formation from 6299' to 6850' w/5 00 gals 15% NE acid by Cardinal Chemical thru 2-3/8" tubing w/perf in anchor from 6834-6838'. Flushed w/40 bbls oil. Inj. rate 218 gpm. Tubing pressure 2700-2100#. Casing packer 1800#.

Swabbed & flowed 80 bbls oil, 10 bbls acid water in 4 hrs. Stabbed 116 bbls oil, 29 bbls ES&W from 3500', 1 run per hr. Kicked off and flowed 18 bbls 31 gravity oil, 17 bbls ES&W in 6 hrs thru 2-3/8" tubing, 3/4" choke.
