Ran 10 Jts (323') 9-5/8" OD 32# Gr H-40 SS casing. Set and cemented at 335' with 275 sacks Regular heat cement. Plug at 323'. Maximum pressure 200#. Circulated approximately 5 sacks. Job complete 7:30AM 7-26-54.

After waiting over 24 hours, tested 9-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 323' to 335' and tested cement below shoe with 400# for 30 minutes. There was no drop in pressure.
