B1 String #2 Ran 6179' 2-7/8" OD casing set at 6199' with Latch in collar at 6158'.

Cement both strings simultaneously with 600 sacks Incor Neat with 4% Gel

containing friction reducing agent. Job complete 1 PM 4-19-63.

Tested both strings w/1000 psi for 30 minutes, Test complete 1 PM 4-20-63.

Tested OK.
