 7-5/8" 26.40#, J-55, casing set @ 5955' w/490 sacks incor w/1/4 gel, 3% salt, .2% Kembrake,  
 plug down @ 10:00 A. M., 3-16, waited on cement 7 hours, temperature survey indicated top  
 of cement @ 3350'. Perforated 7" csg w/two 1/2" holes @ 3348', pumped 125 sacks cement  
 (same as above) thru perfs., plug down @ 1:00 A. M., 3-17, temperature survey indicated top  
 of cement @ 2765'. After 19 hours drilled top plug and cement to 3350'. Unable to get  
 1000# test with rig pump. Tested casing with Halliburton truck with 1000# for 30 min., OK.  
 Rig released.


