2. Acidize perforations 5921-6231' w/4000 gals 15% retarded acid in 8 - 500 gal stages w/50 gal gel acid and 50# benzoic acid between first 4 stages and 75# benzoic acid between remaining stages.
3. Swab, test and place on production.
4. On 24 hr PT ending 11-17-71, F/32 BNO, 34 BW, 20/64 choke, 125# TP, 37° Gravity, 6100 GOR.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
