Tested 11-3/4" OD casing with 600 psi for 30 minutes from 9:00 to 9:30 P.M., December 1, 1962. Tested ok. Drilled cement plug and retested with 600 psi for 30 minutes from 11:00 to 11:30 P.M., December 1, 1962. Tested ok. Job complete 11:30 P.M., December 1, 1962.
