1. Rigged up, installed BOP. Pulled dual strings tubing and packer.
2. Set ret. BP @ 5076' w/3 sks. sand.
3. Squeezed Paddock perfs. 4987-5042' w/100 sks. class H cement w/.5% Halad 9. Reversed out and tested squeeze to 2000#.
4. Drilled out cement to PBTD-5745'.
5. Fraced w/60,000 gal. frac fluid + 90,000# sand in 3 stages.
6. Pulled frac tubing and packer. Ran 2-3/8" tubing w/SN @ 5474', and snubbed back load.
7. Ran pump and rods and placed well on test.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
