We have corrected the Bradenhead pressure in this well as follows:
4/19/77-5/10/77

1. MIRU; pulled rods, pump, tubing; ran casing scraper to 5000' and POH.
2. Set retrievable BP at 4510' w/2 sacks of sand on top.
3. Perf'd 4 holes at 1050'.
4. Squeezed perf's w/100 sacks of Class C cement w/2% CaCl. Waited on cement.
5. Perf'd 4 holes at 300'.
6. Squeezed w/50 sacks of Class C cement w/2% CaCl. Waited on cement.
7. Pressure tested well to 500 psi. Held O.K.
8. Ran production equipment and placed well on production.
9. Cleaned location of all debris.
