We got salty sulfur water. Set cast iron plug. Perforated next zone 8752' -
8757' & acidized with 500 gals. of reg. 15% acid with iron and emulsion control,
swabbed 25 Bbls/hr. 10% load water, 90% oil. Perforated 8710' - 3722', one
hole/ft. Acidized with 500 gals. reg. 15% acid. Perforated 8693' - 8695',
acidized with 500 gals. 15% reg. 15% acid & swabbed both intervals together
15 Bbls/hr., 10% load water & 90% oil. Completed with all 3 sets of perforations
open.
