Commenced drilling operations 6-26-72. Drilled a 17-1/2" hole to 650'. Ran 17 jts. of 13-3/8" 72# & 68# csg. Casing was set @ 637'. Cemented casing with 400 sacks of Class "C" & 8% gel, 2% CACL2, and the second stage was cemented with 350 sacks of Class "C" & 2% CACL2. Plug down at 5:15 P.M. 6-27-72. Circulated out approximately 200 sacks. Waited on cement 18 hrs. Tested casing to 1,000 psi and held for 30 min.; pressure held.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
