On 8-16-72 we moved in and rigged up service unit and ran correlation log 7933' to 7650'. We perforated 7919', 17', 15', 13'; 7868', 66', 64', 40', 38', 36'; 7776', 64', 60', with one .72" hole per interval. Went in hole with tubing and packer and acidized with 1500 gals. of 15% regular acid. 8-23-72 We are now waiting on a pumping unit.
