Cemented casing with 200 sacks Class "C" w/3% D-79 and 200 sacks Class "C" Neat. Plug down @ 9:00 AM 8-13-72. Waited on cement 18 hrs. Tested casing to 1,000 psi. and held for 30 minutes; pressure held.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
