Spudded well at 2:31 P.M. CDT 8-31-78. Drilled well to a total depth of 445 feet RKB. Ran 13 joints (447 feet) of 8 5/8 OD, 23 lb/ft, Grade-B, ST&C casing and landed at 443 feet RKB. Cemented casing with 175 sx of API Class-C cement containing 4% gel and 2% CaCl₂ followed by 150 sx of API Class-C cement containing 2% CaCl₂. Plug down at 4:00 A. M. CDT 9-1-78. Circulated 110 sx of excess cement to pit. WOC 18 hours. Pressure tested casing to 700 psi for 30 minutes. Pressure held okay.
