Drilled 12 1/4" hole and set 406' of 8-5/8" 28 Lb. Grade B Surface Casing and Cemented with 325 sx Class C 2% Cacl. Circulated 100 sx (work accomplished 2-6-80). Oral permission from Jerry Long to reduce 8-5/8" surface pipe setting depth to 400'. Drilled 7-7/8" hole & set 3300' of 5 1/2" 17 Lb. J-55 Production Casing as follows:
