- 08/07/98 Move in, hold safety meeting, rig up, lay down rods, pull tubing, run 5 1/2" casing scraper, shut down.
- 08/10/98 Run 5 1/2" cast iron bridge plug, set at 3360', circulate mud, spot 25 sacks cement from 3360' - 3110', pull tubing to 2400', spot 25 sacks from 2400' - 2150', pull tubing to 1350', spot 25 sacks from 1350' - 1100', pull to 100', circulate 10 sacks to surface, cut off wellhead, put in marker, clean location, move off.

Mud - 25lb. Salt Gel per bbl.
