Spudded well at 9:15 P.M. CDT 10-29-80. Drilled well to a total depth of 434 feet Ran 11 joints (436.93 feet) of 8 5/8 OD, 24 lb/ft, Grade-B, ST&C casing and landed at 434 feet RKB. Cemented casing with 150 sx of API Class C cement containing 4% gel and 2% CaCl followed by 150sx of API Class C cement containing 2% CaCl. Plug down at 10:50 a.m. CST 10-30-80. Circulated 75 sx of excess cement to pit. WOC 18 hours. Pressure tested casing to 700 psi. Pressure held okay.
