Spudded well at 6:15 p.m. 9-26-81. Drilled 12 1/4" hole to a total depth of 415'. Ran 10 joints (414') of 9 5/8" OD, 40.5 lb/ft casing and landed at 412'. Cemented casing with 225 sacks of Class C cement containing 2% CaCl. Plug down at 7:45 a.m. 9-27-81. Circulated 50 sacks of excess cement to pit. WOC 18 hours. Pressure tested casing to 700 psi. Pressure held okay.

*Previous report dated 9-28-81 reported incorrect casing size of 9 3/4" OD.
