- 1) Notify BLM Hobbs office 24 hrs. prior to starting work.
- 2) MI & RU DDU. Install BOP. Pull jt. of tbg.
- 3) GIH w/2-3/8" workstring open ended. Tag bridge plug @ 3495'.
- 4) Spot 20 sks Class "C" neat cmt. mixed to 14.8 ppg to cover perforations & top of Tansil. Displace cmt. in tbg. with 13 bbls. 9.6 ppg mud laden fluid. COOH w/tbg. Calculated top of plug at 3340'. *Tag (must be 50 above top perf)*
- 5) RU casing jacks. Run free-point indicator and cut 5-1/2" csg. at free-point w/jet-cutter. Pull csg. (5-1/2" TOC @ 3130' per temperature survey.)
- 6) GIH w/2-3/8" workstring to 60' below casing cut-off. Load hole w/9.6 ppg mud laden fluid. Spot 35 sks Class "C" cmt. w/2% CaCl₂ mixed to 14.8 ppg from 60' below to 60' above casing cut-off point. PU ±200' and reverse circulate tbg. clean with 9.6 ppg mud laden fluid.
- 7) PU & WOC 2 hrs. Tag top of plug & record. Plug must be at least 50' above casing cut-off. Pull up to 1560'.
- 8) Spot 40 sks Class "C" cmt. w/2% CaCl₂ mixed to 14.8 ppg to cover top of salt section and 8-5/8" casing shoe (1560' to 1450'). Displace cmt. in tbg. w/9.6 ppg mud laden brine. PU & WOC 2 hrs. Tag top of plug and record depth. Top of plug must be at least 1450'.
- 9) PU to 60. Spot 20 sks Class "C" cmt. w/2% CaCl₂ mixed to 14.8 ppg from 60' to surface. Displace cmt. in tbg. w/9.6 ppg mud laden fluid.
- 10) Cut casing a minimum of 3' below ground level. Weld steel plate over casing. Install well marker for permanent abandonment and clean location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
